Limited to a maximum of 4 students in Practice Room 1 and 5 students in Practice Rooms 2 & 3</p>	<p>Provide this guidance in a College-wide email. Provide this guidance via signs on each of the practice room doors. Explaining that failure to observe measures will result in students not being allowed to book and use the rooms.</p>	<p>Head of the Chapel Office to communicate with the Conference Manager, the Head Porter and the Assistant Bursar</p>	<p>1 October 2020</p>	
<p>Surface transmission of COVID-19</p>	<p>Students, contamination from COVID 19 from touching surfaces</p>	<p>All touch surfaces in the room are cleaned every weekday morning, but it is the responsibility of the user to wipe down ALL hard surfaces that have been touched during each individual use of the room (door, door handles, light switches, music stands, piano stools, drum kits, window openings etc), using the WIPES provided.</p>	<p>Housekeeping to provide wipes, Porters' to ensure students adhere to the rules prior to being allowed to book the room.</p>	<p>Housekeeping to provide supplies, Porters'.</p>	<p>1 October 2020, then ongoing.</p>	
<p>Surface transmission of COVID-19</p>	<p>Students, contamination from COVID 19 from touching surfaces</p>	<p>Piano keys must NOT be cleaned with the wipes provided as these damage the keys. If you are the first user of the day (the Porters will notify you of this), it is your responsibility to spray the piano keys and wooden surfaces of the piano with the COVID GUARD spray provided. Once sprayed, leave it for a few</p>	<p>Housekeeping to supply COVID-Guard and to replace the cleaning cloth each morning..</p>	<p>Housekeeping, all users of the rooms.</p>	<p>Ongoing</p>

Surface transmission of COVID-19	Everyone using the room, contamination from COVID 19 from touching services.	All users must maintain excellent hygiene with regular hand washing. No hand to face contact. All to regularly sanitise hands				
Aerosol or droplet transmission of Covid-19	Everyone using the room, contamination from COVID 19.	Students should not arrive early for a room booking to avoid crowding in the lobby area directly outside the Practice Rooms.	Gaps in between lessons and bookings should mitigate against this.	Students, singing teachers.	Ongoing	
Contamination from COVID 19	Students, contamination from COVID 19.	Any student feeling unwell or displaying symptoms of Covid 19 should immediately cancel any booking made and not enter the Music Practice Rooms.
